**LOCATION:** Flames Natatorium at University of Illinois Chicago—901 West Roosevelt Road, Chicago Illinois

**FACILITY:** Eight-lane 25-yard competition pool. The start end and the turn end of the pool are 16' 0" deep. Lanes are 7'6" wide and are separated by 6" Wave Eater Advantage anti-wave lane lines. The touch pads will be Colorado Aquagrips non-slip. The timing system is a Daktronics OmniSport® 2000 with an 8-lane readout board. There is a separate area of the pool that will be designated for warm up/swim down. Seating is available for 1200 spectators.

**QUALIFYING TIMES:** 2009 Championship Time Standards are included. Only swimmers having achieved qualifying times by 6:00 PM, Tuesday, March 3, 2009 are eligible for this meet. Entry times may be submitted in short course yards, short course meters or long course meters. Please highlight and note ("SCM" or "LCM") next to all non-conforming entry times. Fax/Email entries for times achieved between 6:00 PM March 3, 2009 and 1:00 PM Monday, March 09, 2009 must be submitted by 1:00 PM March 09, 2009 on the attached Fax/Email entry form.

**ENTRY FEES:** \$5.00 per individual event, and \$15.00 per relay entry. A swimmer surcharge of \$2.00 per swimmer entered in at least one individual event must be included with entry.

**ENTRY DETAILS AND DEADLINE:** This meet will be using USA Swimming On-Line Meet Entry at:

Entries may be submitted online beginning on January 12, 2009 (12:01AM CDT) and must be completed by Tuesday, March 3, 2009 6:00 PM CDT. You will be required to pay for the online entries with Visa, MasterCard, American Express, or Discover. To pay by check please contact Illinois Swimming Office for payment instructions. Once you complete your online entry, you will be sent a confirmation email. You may update your OME entry at any time prior to the entry deadline. You can also add events to your entry but you cannot delete events after you have paid for them. Bring all communications with you to the meet in case of problems with your entries.

**ENTRY PROCESS:**

"Applied For" registration numbers will not be accepted; registration forms may be obtained from the ISI office, 847-824-1596, 3166 S. **EVENT LIMITATIONS:** Swimmers may swim a maximum of six (6) individual events. Swimmers may enter as many events as they have met the qualifying time standard; however, swimmers competing in the 11-12 and 13-14 age groups may compete in no more than three (3) individual events per day. Swimmers competing in the 10 & under age group may compete in no more than four (4) of their six (6) individual events per day.

## INDIVIDUAL EVENTS:

1. All 10 & under individual events will be conducted as timed final events.
2. All 11-12 individual events except the 500 free are preliminary/final events with consolation and championship final heats. The 500 free is a timed final event with the fastest seeded heat swum in the finals session.
3. All 13-14 individual events except the 500 free, 1650 free and 400 IM are preliminary/final events with consolation and championship final heats. The 500 free, 1650 free, and 400 IM are timed final events. The fastest seeded heat of the 500 free and 400 IM will swim in the finals session. Preliminary heats of the 500 free and 400 IM will be swum slowest to fastest.
4. All heats of the 1650 free will be swum at the conclusion of the preliminary session of Day 3 (Sunday) where the fastest seeded women's heat will swim first, the fastest seeded men's heat will swim second. The second fastest seeded women's heat will swim third; the second fastest seeded men's heat will swim fourth, continuing in this fashion until all heats are swum. A 30-minute warm-up period will precede the first heat.
5. Swimmers with either an 800 or 1000 freestyle qualifying time may enter the 1650 freestyle event. Swimmers must be entered at the slowest non-conforming 1650 freestyle time standard. For the 2008 Short Course Age Group Championship the 13-14 Girls Qualifying Time in the 800/1000 free for this rule is 11:28.79 SCY, 10:23.79 LCM, 10:02.69 SCM, The 13-14 Boys Qualifying Time in the 800/1000 free for this rule 11:10.59 SCY, 10:11.99 LCM, 9:46.79 SCM

## RELAY EVENTS

1. Relay entries may be proven as actual or aggregate ("add up") times. For purposes of proving entry times, a swimmer may be listed on only one relay team entered in each event. Each time used as part of an aggregate entry time must include acceptable proof-of-time.
2. All relays are timed final events. The fastest seeded heat of each relay event in the 11-12 and 13-14 age groups will swim at the end of the finals session. All remaining seeded heats will be swum at the beginning of the preliminary session, slowest to fastest. EXCEPTION: When there is less than one heat plus three entries all teams will swim in the finals session.
3. Relays will be pre-seeded like the other events.
4. **There will be no relay check-in procedures** each coach shall pick up relay entry forms from the clerk of course, on which he/she shall list the competing relay swimmers, their first and last names, ages, and order of swimming, for each entered relay. Upon reporting to the starting blocks, immediately prior to the start of the relay heat in which such team is entered, the completed relay entry form shall be handed to the head lane timer. No change will be permitted thereafter and failure to present the head lane timer with written list of relay swimmers shall prevent such team from competing.

**SEEDING:** Entries shall be seeded according to USA Swimming rules. Entry times conforming to course length for this championship meet (SCY) shall be considered "conforming times." All other times meeting the appropriate standard shall be considered "non-conforming times." The order of seeding for this meet is Short Course Yards (SCY), Short Course Meters (SCM), and Long Course Meters (LCM).

**SCRATCH MEETING:** Thursday March 12, 2009 at 6:00 to 6:30 PM at UIC Pool

**SCRATCH PROCEDURES:** ISI Championship scratch rules and procedures will be in effect at this meet. Scratches for the finals shall be made with the Administrative Referee. Scratches from preliminary events shall be made using the scratch box at the clerk of course. The scratch deadline for preliminary events is as follows:

- Thursday 6:30 pm For Friday events
- Friday 6:00 pm For Saturday events
- Saturday 6:00 pm For Sunday events

**COACHES MEETING:** Coaches meetings will be held 15 minutes prior to the start of each prelim session if needed. Each team or unattached swimmer must be represented at this meeting and is responsible for all information and/or procedures.

**READY ROOM & AWARDS CEREMONY:** Swimmers in the championship finals should report to the ready room area two heats prior to their event. Consolation Heat athletes should report directly to the blocks. Awards for women and men will be presented after each men's championship final heat. Awards for day one and Relay awards for day two and day three events will be presented at the beginning of the following evening's finals.

**AWARDS:** The Don Drumm Award will be presented to the overall team champion. Additionally, team awards will be given to the top three combined teams. Other awards will be given to the top 8 finishers in individual events and the top three finishers in relay events.

**MISSED QUALIFYING TIMES & FINES:** Entry times will be taken from the SWIMS database, custom times may be entered, however all times not from SWIMS are subject to 'proof of time' at the clerk of course table. Coaches will be notified of the need to prove times. If a time cannot be proven prior to the scratch deadline, then the swimmer will not be seeded.

**BREAKS:** Ten-minute breaks with the pool open for warm-ups are scheduled at the following times:

- At the completion of the relay event of each session
- Prior to the first heat of the of the 500 free event in the preliminary session
- At the discretion of the meet referee

**MEET RESULTS:** Meet results will be available via .PDF file on the Illinois Swimming website. Live results can be found on the host site at [www.academybullets.com](http://www.academybullets.com) .

**MEET COMMITTEE/TECHNICAL JURY:** The Meet Director and the Age Group Vice-Chair will select the Meet Committee. The committee will consist of a coach, an athlete, and 1-3 other individuals.

**WARM-UP:** ISI warm-up and safety procedures will be in effect.

**DECK ACCESS:** Current USA Swimming membership is required for coaches and working officials to be on deck. Coaches must be current with all safety certifications. Coaches and officials must display USA Swimming credentials at all times while on deck. Credentials will be checked for all Coaches at the Clerk of Course table prior to receiving team packet.

**TIMERS:** Each team with swimmers in the meet must provide timers. A list of lane assignments for each team will be posted after the entry deadline. A club timer coordinator with phone number and email address must be listed on your Team Summary and Release Form that is submitted with your entry.

**OFFICIALS:** This meet has been designated as an Officials Qualifying Meet. Officials interested in working this meet should submit the application, found on the ISI website under the Officials tab. They can also direct questions regarding officiating to [MeetOfficials@ilswim.org](mailto:MeetOfficials@ilswim.org). A mandatory briefing for all officials working the meet will begin 1 hour before the start of each session.

**PUBLICITY:** Any swimmer competing in the championship final of an event for the first time at this meet should be sure that his/her biographical information is on file. Forms will be located at the Clerk of Course and Admin Tables.

**ADMISSIONS:** Admission is \$6.00 per day. Special 3-day heat sheet package (1 daily 11 & over prelim heat sheet, 10 & under heat sheet and evening final heat sheet) is available for \$18.00 (daily heat sheets for either preliminaries or finals will be distributed on the corresponding day's competition only). Individual heat sheets are \$4.00 for prelims & timed finals sessions and \$2.00 for finals.

**PARKING:** Parking is controlled by the UIC Parking Office who establishes all fees associated with parking. There is no free parking. The primary parking lot for all events in the UIC Athletic Facilities is Lot 5, located just north of the Physical Education building. The entrance to this lot is located on Morgan Street between Roosevelt Road and Taylor Street. In the event Lot 5 is not available, UIC Athletics and the UIC Parking Office will open the next closest available lot.

**NO CHAIR POLICY:** Due to safety concerns at UIC Natatorium, chairs of any type (lawn chairs/folding chairs/etc...) **WILL NOT BE ALLOWED** into the facility. This has been deemed a security concern as it would create an evacuation hazard if a problem should arise. There are no exceptions to this rule. Spectators refusing to cooperate will be asked to leave the premises. If you require special seating then please inform the person at the ticket table and they will be able to assist you. Only coaches will be allowed to bring chairs on deck pending approval from the safety marshal.

**FOOD & SWIM SHOP:** The Swim Team Store will be onsite selling swimming related items and concessions will be available.

**LOCKER ROOMS:** Locker room facilities are available on the deck level of the pool for changing purposes only. No lockers will be available for storage.
